POLL RESULTS OF THE 2024 ANNUAL GENERAL MEETING

At the Annual General Meeting (the “**AGM**”) of Excellence Commercial Property & Facilities Management Group Limited (the “**Company**”) held on Wednesday, 12 June 2024, all the proposed resolutions as set out in the notice of the AGM dated 29 April 2024 were voted by way of poll. Unless the content otherwise requires, capitalized terms used in this announcement shall have the same meanings as those defined in the Company’s circular dated 29 April 2024 (the “**Circular**”).

The Company’s branch share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, acted as the scrutineer for the vote-taking at the AGM.

As at the date of the AGM, the total number of issued shares of the Company was 1,220,348,000 shares, the holder of which were entitled to attend and vote at the AGM. There were no restrictions on any shareholders to cast votes on any of the proposed resolutions at the AGM. No shareholders were required to abstain from voting on any of the proposed resolutions at the AGM under the Rule 13.40 of the Rules Governing the Listing of Securities on the Stock Exchange (the “**Listing Rules**”). There were no shares entitling the holder to attend the AGM and abstain from voting in favour of any of the proposed resolutions at the AGM under Rule 13.40 of the Listing Rules. No shareholders had stated their intention in the Circular to vote against or to abstain from voting on any of the proposed resolutions at the AGM. All Directors attended the AGM.
